Addition new bullet point: Board members are eligible for a 50% reduction in the cost of all professional development opportunities.
Art 27 (new 24) Indemnity	..." This holds true for any other costs or expenses which he/she had to defray during or because of business he/she concluded which was related to his/her duties as a member, except for anything from his/her fault."	Removed

Art 29 (new 27) Resignations and Dismissals	"An officer can tender his/her resignation by serving written notice to this effect to the Secretary of the Corporation. His/her resignation takes effect as of the reception of such written notice as of the date stipulated in his/her notice of resignation. If an officer of the Board of Directors resigns, his/her seat on the Board, he/she also relinquishes his/her status of Officer of the Corporation as the case may be as of the effective date of his/her resignation. The Board of Directors has the power to dismiss an Officer of the Board. He or she ceases to exercise his/her functions as of his/her dismissal."	Changed: Redundant – art. 19 New version 1.
